

WATER DEPARTMENT **BILLING POLICY- MIROCO**

The City bills in two month increments. Service is not transferred before the receipt of a signed Application for Water and Sewer Service card. Billings remain in owner's name even if a tenant occupies the premises. For new developments including single family dwellings, effective date of service begins with the date of meter installation. Payment is due within 10 days from the postmarked date on the bill, and is considered delinquent after 30 days, per City of Depoe Bay Ord. #251.

Charges & fees:

- A. Pursuant to agreement water, service rates for customers in the former district shall be the city's base and usage rates plus an additional base charge for annual water debt service. The additional base charge is calculated and revised annually with the rate being effective each July 1st through June 30th.

- B. New customer processing fee: \$25 (on first bill).
- C. Posting of Turn off Notice (pink door knocker) on delinquent charges: \$30 each notice.
- D. Turn on or turn off (either for past due accounts or on customer's request): \$25 each action.
- E. Lien filing or satisfaction of lien filing: \$65 each action.
- F. "Non-Sufficient Funds", "Account Closed" or any other reason causing the check to be returned: \$25 per check, per City of Depoe Bay Res. #262.
