1 V. STATE REVENUE SHARE FUNDING 2 This item was postponed until after discussion of Item VI. Open Discussion/Public Input. 3 4 VI. OPEN DISCUSSION PERIOD/PUBLIC INPUT 5 Rick Beasley thanked everyone involved in the budget process. He expressed a concern about the next 6 three to five years, saying that of 17 revenue sources, 15 are in decline. He encouraged the committee to 7 find other sources of revenue, and suggested pursuing having wireless communications companies pay 8 franchise fees. He advised that the city should preserve its priorities, with employees and Neighbors for 9 Kids being high on the list. He also suggested the city create a municipal court, and implement a sales 10 tax and a tax base. 11 12 Return to Item V. STATE REVENUE SHARE FUNDING 13 Murray explained that the committee must discuss whether or not the City wishes to participate in the 14 revenue sharing from the State. This funding comes from cigarette, liquor, and gasoline taxes. Motion: Leoni moved that the Budget Committee recommend to the City Council to accept State 15 16 Revenue Share Funding and to apply \$15,000 to the Harbor Reserve. Brown seconded the motion. 17 18 Connors said it was moved and seconded, and called for discussion. There was brief discussion about 19 how to spend liquor tax dollars. 20 21 Vote: Motion passed. 22 Ayes: Brown, Cameron, Connors, Davilla, Hunter, Leoni, Silver, Spores, Taunton, White, 23 Wideman, Zimmerman 24 25 VII. SET DATE FOR NEXT MEETING 26 The next meeting was scheduled for 6:30 PM on Monday, May 18, 2009, immediately following the 27 Urban Renewal Budget Committee meeting at 6:00 PM. 28 29 Because acquiring law enforcement has not been accomplished, Silver said he would like the committee 30 to consider releasing some of the over \$300,000 in collected transient room tax revenue devoted to 31 public safety/law enforcement. Potholes and crosswalks were specifically mentioned, with additional 32 safety-related projects potentially being identified as the budget process proceeds. 33 34 VIII.
