31 Applicant: Big Whale Cove, L.L.C.

32 Application: Request for Planned Development, Zone Change, and Street Vacation

33 Map and Tax Lot: 09-11-17-BC #100, 200, 300, 400, 500, 600, 700, and 800

34 Location: South end of Depoe Bay, west of Highway 101 and south of Oceana St.

36 Lewis noted (in response to a Planning Commissioner's question posed at the February 13, 2008
37 Meeting) that he looks at the Gross Area of the Existing Site to determine if the Proposed Development
38 meets the DBZO Regulation requiring *that a Planned Development shall have a minimum of two (2)*
39 *contiguous Acres, exclusive of Street Right-of-Way* (overall intention is to ensure that existing Street
40 Right-of-Ways are not considered as part of the Proposed Planned Development). He summarized the
41 Findings, Conclusions, and Final Order (copy attached to original of these Minutes) specifically
42 identifying the Amended Conditions of Approval as stated in the February 13, 2008 Motion towards

1 Preliminary Plan Approval. Connors asked if the Commissioners had any questions to address to the
2 City Planner. There was none.

3 Motion: McGavock moved to approve the Findings, Conclusions, and Final Order for Case File #1-PD-
4 PC-08 (Whale Cove Planned Development) as prepared by the City Planner. Hough seconded the
5 Motion.
