11 Goddard called the Meeting to order and established a quorum at 6:02 P.M.

37 A. Depoe Bay Disaster Warning System
38

39 Goddard opened the discussion. Attendees in the Audience included Michael Dane, Lincoln County
40 Emergency Communications, Primary Assignment Depoe Bay Emergency Operations and Brady
41 Weidner, City Field Supervisor, City of Depoe Bay. Lengthy discussion ensued regarding:
42

- 43 • Hageman summarized research he conducted on Siren Systems.
- 44 • Steinke said that Tierra del Mar obtained their first Warning Siren from the Trojan Nuclear Plant.
45 Tierra now has a second Warning Siren that may have been obtained from the Trojan Nuclear
46 Plant as well. Sirens may still be available from the Umatilla Depot.
- 47 • Dane has been in contact with the Tillamook Emergency Management Director who has
48 researched that 30 Sirens are available from the Umatilla Depot. The biggest problem with the
49 Umatilla Depot Sirens is bringing them into compliance. Hageman stated we may not need to
50 worry about compliance at this time (since compliance standards won't be in place for five years).
51 Dane questions whether or not the Sirens can be tied into LinCom or if a button has to be pushed
52 manually.

- 1 • Dane said that Radio Shack, Lincoln City, has material available on NOAA Radios and Sirens.
2 • Hageman will call two companies for information and pricing on modern Sirens.
3 • Dane said that Lincoln City's Community Emergency Response Team (CERT) recently received
4 a Homeland Security Grant for training and equipment, i.e. trailers. To receive a Homeland
5 Security Grant, the applicant must be certified by the National Incident Management System
6 (NIMS). Dane is NIMS Certified and offered his 'signature' for the City. Homeland Security
7 may have funds available for Siren/Warning Systems. Dane stated that he is pretty sure that Pery
8 Murray, City Recorder, is NIMS Certified.
9 • Dane will check on Goddard's comment that the State of Oregon Emergency Services received
10 \$50 million of Federal Funding for Tsunami Readiness.
11 • Goddard will contact the Coast Guard about attending the November 10, 2010 Planning
12 Commission Meeting.
13 • Dane will contact Lt. Landers of the Lincoln County Sheriff's Office about coming to the
14 November 10, 2010 Planning Commission Meeting.
